(15) Description of equipment:

The intrinsically safe, rugged smartphone type IS740.2 is designed for voice and data communications in explosion hazardous areas of zone 2 and 22. It is equipped with cameras (also no camera version is available), GPS, acceleration sensor, Dual-SIM, vibration motor, 4G (LTE), Bluetooth, WLAN and NFC technology. The software is based on the ANDROID or Microsoft WINDOWS operating system.
