## Schedule

### 13 Description of Equipment

The iCORDEX iPhone Case is an ATEX Category 3 case to allow the use of an iPhone 14 Pro Max, iPhone 15 Pro Max or iPhone 15 Plus in a Zone 2 or Zone 22 hazardous area.

The phone case has a silicone jacket to provide drop and impact protection.

The model numbers are as follows:

Variant model	Description
14PMx-3	Enclosure for iPhone 14 Pro Max
15PMx-3	Enclosure for iPhone 15 Pro Max
15PSx-3	Enclosure for iPhone 15 Plus

### 14 Special Conditions for Safe Use:

- The equipment must only be used in areas where there is a low risk of mechanical damage.
- The restricted breathing test port shall only be removed in the safe area.
- The battery is not user replaceable, do not charge in explosive atmospheres.
- Do not open the enclosure in a hazardous area, if opened, the enclosure shall be subjected to a routine restricted breathing test as detailed in clause 12.2.2.1.1 of EN IEC 60079-15:2019.

- The manufacturer shall conduct a routine restricted breathing test on each enclosure in accordance with one of the procedures detailed in clause 12.2.2.1.1 of EN IEC 60079-15:2019.
